2024 Stallion Service Contract Best Brew at the Bar

This Stallion Service Contract is made and entered into this day and month written below Verneda Pabon/Pabon Performance Horses ("Stallion Owner"), and Prince Farm LLC, Palmetto FL ("Stallion Manager"), and ______ ("Mare Owner"). These parties agree as follows:

1. Mare Owner agrees to breed the mare

Mare NameRegistration NoDate of Birthto Stallion standing at Prince Farm LLC, Palmetto FL for the 2024 season and to pay the Stallion ServiceFee together with the Chute Fee and other reimbursable expenses set forth herein.

2. The Stallion Service Fee shall be \$2,000.00, plus a Chute Fee of \$375.00. A Credit Card is required for FedEx or UPS, insurance and deposit on equine shipper.

3. The Stallion Service Fee shall include the following:

A. Collection Fee for the first shipment, provided it is made on a regular breeding day (Monday, Wednesday, Friday) and the breeding farm is notified prior to 5:00pm Eastern Time the day before collection. Priority is given to mares on farm, next for orders in the order they are received (except that first time shipments are given priority over subsequent shipment requests) Semen orders can be made prior to the shipment day and then confirmed before 7:30am on collection day to be placed on the list earlier. All shipping charges, to received semen shipment in an Equine Shipper or Equitainer and return to Prince Farm are the responsibility of the mare owner. The Stallion Manager shall not be responsible for the cost arising from shipments lost, damaged or delayed in transit, or condition of cooled semen upon delivery. We have no control of the shipment after it leaves our custody.

4. Subsequent Shipments. For each shipment following the first shipment, the Mare Owner shall be responsible for the following:

- A. \$200.00 Semen Collection Fee for next day FedEx or UPS service plus the FedEx or UPS freight.
- B. If same day service is necessary, a \$200.00 Semen Collection Fee plus an additional
 \$300.00 airport courier fee will be charged.



C. All additional charges and/or unpaid balances shall be automatically billed to your credit card unless otherwise agreed. Charges may include but are not limited to collection fees, off day charges, airport courier fees, and airline freight charges.

5. Any shipments requested on Off Breeding Days, including the first shipment, will be charged an additional fee of \$200.00 if available.

6. Stallion Manager will use Equine Express Shippers weather permitting.

7. Mare Owner shall attempt with reasonable diligence to settle mare; if however, for any reason the mare does not settle, Mare Owner will hold Stallion Owner and manager harmless.

8. The breeding season for shipped semen begins February 1st and closes June 1st at which time all shipments will be discontinued.

9. If the mare does not settle in 2024, the Stallion Owner will honor the Stallion Service Fee on the mare originally booked (unless otherwise mutually agreed in writing between Mare Owner and Stallion Owner) for the following year only the 2025 season. Chute fee will be charged along with FedEx or UPS if applicable.

10. Stallion Owner guarantees live foal from the breeding contracted for herein. Live foal is defined as a foal that stands and nurses without assistance. Should the Mare prove not to be in foal in the year bred or lose her foal, or should the foal not stand and nurse without assistance. Mare Owner shall notify Stallion Owner in writing within one week of foaling date (or the date the mare is proved not to be in foal or loses her foal); such notice shall be accompanied by a statement from a licenses veterinarian verifying that the foal is not "live" as defined above or has been lost as stated above. Under the foregoing circumstances and upon receipt of the specified notice, it is agreed;

- A. Stallion Owner shall give Mare Owner (1) one season to the Stallion, per the terms of Paragraph 9, the following year only and to the same Mare originally booked.
- B. If mare Owner fails to deliver the Mare for rebreeding the following year, then any and all fees paid shall not be refundable; the right to rebreed is thereby canceled and Stallion Owner is released from any further obligation.

11. This contract shall not be transferable by Mare Owner. A Breeders' Certificate will be issued when the Mare Owner notifies the Stallion Owner of the birth of the foal and only after payment of all bills due on the Mare have been received. This agreement constitutes the entire agreement between the parties, any amendment to or modification of the terms of this agreement must be in writing.

12. Should it be necessary for the Stallion Owner to employ an attorney to enforce any of the terms of this agreement, including collection of money owned, Mare Owner shall pay all reasonable attorneys' fees, costs of suits, and other expenses reasonably related to enforcing this agreement.



13. Embryo Transfers. If two (2) embryos are obtained from a single flush, another breeding fee must be paid in order to receive another Breeders' Certificate. This contract is for one (1) Breeders' Certificate only.

14. It is further agreed that should the stallion die or become unfit for service this contract shall become null and void, and any money paid as part of the Stallion Service Fee less the nonrefundable booking fee and shipping/collection fees, shall be refunded to the Mare Owner.

15. Shipping Container Return Prince Farm utilizes a limited number of specialized "Containers" to insure the viability of fresh semen during shipping.

- A. Mare Owner or Agent agrees to shop the Container back to Prince Farm no later than five (5) days following the date Mare Owner or Agent receives the Container
- A late fee of \$25.00 per day will apply if the Container is not received by the Farm within five (5) business days following the date received.
- C. The Container must be returned clean and undamaged. If coolant bags or Styrofoam container are missing or damaged, Mare Owner or Agent will be charged for replacement of damaged parts or, if applicable, for the replacement cost of the container. New container is \$50.00 plus applicable shipping fees and sales tax.
- 15. Requirement Prior to Shipment:
 - A. Original Signed Contract, \$2,000.00 Stallion Service Fee plus chute fee of \$375.00 and Owner Information Form
 - B. Shipping Fee
 FedEx or UPS \$350.00 per Shipment
 Counter to Counter \$400.00 per Shipment
 - C. Credit Card Authorization Form (All Credit Cards have a 4% fee added)
 - D. Copy of the Mare's Registration Paper both sides
